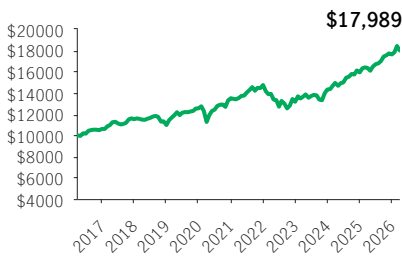

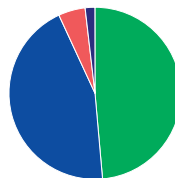

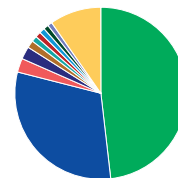

**ASSET ALLOCATION %**



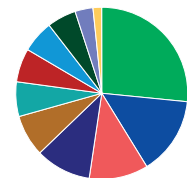
