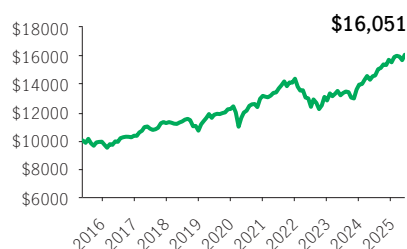

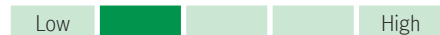

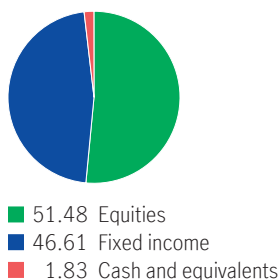

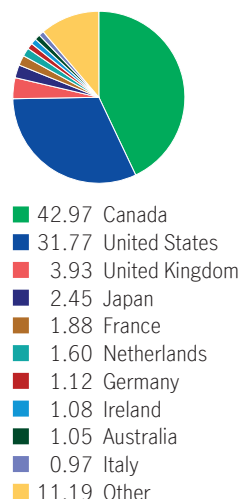

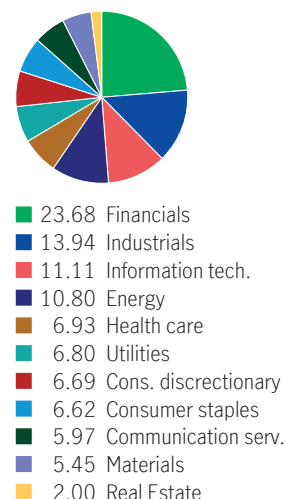
### ASSET ALLOCATION %
